# HIT News

## Medicaid Beneficiaries at Risk of Losing Coverage Report sent to Primary Care Providers Statewide via SHARE HIE

At the start of the pandemic, Congress enacted the Families First Coronavirus Response Act (FFCRA), which included a temporary requirement that Medicaid programs keep people continuously enrolled, and, in exchange, states received enhanced federal funding. As part of the federal omnibus bill that was enacted in December of 2022, Congress set March 31st, 2023, as the end to the continuous enrollment provision. Department of Human Services, which oversees Arkansas Medicaid, has taken several steps to educate Medicaid beneficiaries and provide them with the necessary steps to reduce coverage disruptions. SHARE, Arkansas' only statewide HIE has collaborated with Arkansas Medicaid to provide notifications to primary care providers on the potential impact of losing Medicaid Beneficiaries. SHARE leveraged its existing patient groups and existing notification services to send out targeted reports to primary care providers throughout the state.

The State Health Alliance for Records Exchange (SHARE) HIE securely provides a comprehensive picture of a patient's care across providers and regions with Access Medical Clinics.

Access Medical Clinics now has over 35 clinics statewide from Garfield to El Dorado and growing. Patient's records are updated 24/7 with each encounter with the connection between SHARE and their Athena EMR. Connecting practitioners to timely and actionable patient information facilitates care coordination and promotes cost-effective solutions. SHARE is a gateway to real-time, actionable patient data to improve routine care, emergency care, or care management. Data can be queried directly from the Athena EMR or accessed through the SHARE Virtual Health Record (VHR) Portal. With increased patient mobility and expanded healthcare delivery options, SHARE provides access to the bigger patient picture 24/7.

### *Types of Data Exchanged with Access Medical Clinic with SHARE HIE*

- **Demographics: Name, Gender, DOB, Race, Ethnicity, Language, Insurance Information**
- **Allergies, Medication Allergies, Immunizations, Medications, and Observations**
- **Clinical Summaries and Bi-directional Continuity of Care Documents (CCDs)**
- **Diagnoses, Procedures, and Discharge Summaries**
- **Lab Tests, Values, Results, Other Diagnostic Results, and Problem Lists**
- **Radiology Reports**
- **Vital Signs: Height, Weight, and BP**

HIEs are crucial for connecting communities and ensuring patient medical records are always available. As value-based care brings more focus to patient social needs, HIEs allow organizations such as first responders, prison clinics, organ donation organizations, schools, social determinants of health screeners, and behavioral health and IDD centers to connect and share patient information.
